WHEREAS, the District has been operating for a considerable period of time with at least one vacancy and has had repeated difficulties finding interested and qualified candidates willing to serve on the Board;

WHEREAS, ongoing vacancies on the Board have made achieving quorum for meetings more onerous and have frequently resulted in the rescheduling of regular meetings.

NOW, THEREFORE, be it resolved by the Board of Trustees of the Fresno Westside Mosquito Abatement District, as follows:

- 1. Pursuant to Health and Safety Code section 2025 (b), the Board hereby formally requests that the Fresno County Board of Supervisors reduce the number of appointees to the Board of Trustees from five members to three members.
- 2. The District Manager is hereby directed to advise Fresno County officials of this Resolution and to otherwise implement the Board direction contained herein.

SB 553 Summary and Workplace Violence Prevention Plan Update

Summary: On September 20th, 2023, Governor Newsom signed into law SB533 requiring employers to implement a series of policies to prevent workplace violence. Thus builds on existing requirements and requires integration of workplace violence prevention plans into the District's current Injury and Illness Prevention Program.

- 7. Emergency Response Procedures including alerts and evacuation or sheltering plans [(G)].
- 8. Training Development and Provision outlining the process and content [(H)].
- 9. Hazard Identification and Evaluation including periodic inspections and employee reports [(I)].
- 10. Hazard Correction Timelines consistent with regulatory standards [(J)].
- 11. Post-Incident Procedures for response and investigation [(K)].
- 12. Review and Revision of the Plan at least annually or after incidents [(L)].
- 13. Additional Provisions as required by the division and standards board [(M)].

Violent Incident Log [(d)(1)(A-C)]:

- 1. Record Every Incident with comprehensive details while omitting personal identifying information.
- 2. Log Review during the plan's periodic reviews.

Training Requirements [(e)(1-3)]:

- 1. Initial and Annual Training on the plan, reporting mechanisms, and hazard-specific information.
- 2. Additional Training when new hazards are identified or the plan is changed.

Record-Keeping [(f)(1-6)]:

- 1. Maintain Hazard, Training, and Violent Incident Logs and investigation records for five years.
- 2. Availability of Records to employees, representatives, and the division upon request.



Enforcement and Penalties [(g)]:

- Understand the process for the issuance of citations, penalties, and appeals.

Future Standards [(h)]:

- Stay Informed about standards to be proposed by December 31, 2025, and adopted by December 31, 2026.

Action Items:

- 1) Current Policy 2205 Security and Workplace Violence prohibits violent and threatening actions but does not meet the standards of a *Workplace Violence Prevention Program*.
- 2) Amend Policy 3020: List of Safety Programs , List *Workplace Violence Prevention Program*
- 3) Records of Workplace Violence must be maintained for a period of five years, Amend Records Retention Schedule.
- 4) Workplace Violence Training is currently included in the annual training, but may need updating



Manager's Report, February 2024

1. Environmental Summary

Temperature Patterns

- Max Temperature: The temperatures in Firebaugh during February 2024 peaked at 72°F, with an average high of 62.45°F, and the lowest high temperature recorded was 50°F.
- Average Temperature: The overall average temperature for the month was 59.92°F, with the monthly average falling to 53.59°F, and the lowest average temperature recorded was 45.54°F.
- Min Temperature: The lowest temperatures observed dropped to 36°F, with an average low of 45.62°F, and the highest minimum temperature was 53°F.

These temperature ranges suggest mild to cool weather conditions throughout the month, which are typically less conducive to high mosquito activity, especially during the cooler nights. However, the higher end of these temperatures can support mosquito breeding and activity, particularly during warmer days.

Precipitation

- Precipitation: February saw a maximum daily precipitation of 0.75 inches, with an average of 0.11 inches, and days with no rainfall. The total precipitation for the month amounted to 3.21 inches.
- Snow Depth: There was no snow accumulation throughout the month, which is typical for Firebaugh's climate.

The recorded precipitation indicates that there were several wet days in February, contributing to the overall monthly total of 3.21 inches. While this is not excessively high, it is sufficient to create standing water in some areas, providing breeding grounds for mosquitoes. The relatively low overnight temperatures impede development of mosquitoes.

2. Financial Updates

- a. Solar Project:
 - i. Solar Negotiators was contacted regarding the delay in completion of the solar project. While no specific date of completion was included in the contract, after some discussion, it was agreed that the final bill would be reduced by \$1000 to account for the delays. In addition, Solar Negotiators agreed to provide support for the District's efforts to obtain elective payments under the IRA, for the solar project.
 - ii. The solar project was registered with the IRS to receive credits under the IRA. The District must complete a "blank" tax return during the regular tax filing period. The District attempted to apply for a low

income enhancement, but the program was beyond capacity and we would be unlikely to receive the designation.

- b. *SDRMA*, *Workers Comp Inaccuracy:* During a routine review of proposed renewal rates it was observed that our MOD rate had risen over the last couple years without explanation. Upon further investigation, it was found that an incident that occurred in May of 2022 at the Madera MVCD was improperly associated with our account. SDRMA was contacted and indicated they will be making the necessary changes. We will follow up with SDRMA and will request direct notice of any worker's comp incidents in the future (you had to run a loss report to find this one).
- c. Aircraft Repair: With the cylinder replacement and additional work needed, the total aircraft repair for the year came in at a little over \$100,000. This exceeded initial estimates, but additional items were found to need repair during the engine removal and replacement. Ty reports that the aircraft is now in much better condition, but will need to be run periodically throughout the winter.
- 3. <u>Staffing and Administration:</u> Our first seasonal will start on 3-18-24, An additional one or two seasonals will be brought on in May and June depending on the needs. The shift to habitat-based operations is changing our staffing needs, and we will remain flexible to hire as needed to support operations.

The District's aerial program is in the process of changing. Our primary pilot and airplane manager has entered into a program for a new position and will have limited availability for the upcoming season and is uncertain to continue offering the service. We are working with Merced MAD and considering formation of a JPA to address securing a pilot and shared airplane costs.

- 4. <u>Operations Summary:</u> Field operations were just beginning to start in February. Technicians inspected known sources after the rains but found little breeding at this point. Until temperatures steadily increase we do not expect high mosquito activity. Full operations will resume in the month of March. The District will be
- 5. <u>Legal, Regulatory, and Legislative Update:</u>
 - a. Legal:
 - *i. SB 553:* In July of 2024, SB 553 requires updates to districts' Workplace Violence Prevention programs and integration into district IIPP. This will be completed over the next couple months.
 - ii. District Warrant: The District applied for and received its administrative search warrant for the 2024 calendar year. The initial draft was returned with a few clarifications needed and a request for statutory authority but was amended and returned successfully.
 - b. Legislative: MVCAC is sponsoring legislation, SB 1251, by Senator Stern that would compel private electric utilities, like PG&E to enter into vector

- management agreements with vector control agencies. Utility vaults are a considerable source for *Aedes aegpyti* production in the Central Valley.
- c. Regulatory: A letter on behalf of the District was submitted to EPA to support the full registration of MosquitoMate's Wolbachia mosquito in Aedes aegypti which would be the next step in making it commercially-available in California (pending CDPR approval).
